

**CITY OF DEL RIO  
SANITARY LANDFILL RULES**

**DAYS OPEN:** Monday – Friday: 6:00 AM – 4:45 PM  
Saturday: 6:00 AM – 1:45 PM  
Closed on Sunday

**CHARGES:** \* All vehicles are weighed upon entering and exiting the landfill to determine appropriate charges.

Residents of Del Rio household trash/yard rubbish – No Charge

\* All commercial customers will be charged for landfill use. Customers with delinquent water/sewer bill that shows payments of City's garbage fee, and a valid photo ID, such as a driver's license cannot use the landfill until the account is current.

Car Tires (16" or smaller)	\$2.00/tire
Truck Tires (16" – 24.5")	\$5.00/tire

All uncovered loads will be charged 200% percent of the current gate fee and gate fee

There is no charge to residents of Del Rio for dumping routine items such as residential trash, brush, limbs, leaves, furniture, grass and appliances.

All building materials including, but not limited to, concrete, asphalt, metal waste, waste or rubbish from building renovation or remodeling, and materials removed from buildings or structures as a result of renovating or remodeling, rock, dirt, will be charged \$31.29 per ton as stated above.

**COLLECTION STATION:** A collection station is available at the landfill for: used oil, oil filters, anti-freeze and used vehicle batteries, at no charge for residents that present a current utility statement.

**NO DRUMS and 5 gallon at a time**

**WOOD CHIPS (Mulch)** – available to all residents of Val Verde County at no charge.

**PROOF OF CITY RESIDENCY:** A valid driver's license and current water billing statement must be presented to the gatekeeper at the landfill to verify proof of residency. A person disposing of trash for another person will be charged the posted rate.

**TRANSPORTING:** All trash must be covered with a tarp or some other material to prevent littering. Littering laws will be strictly enforced.

**RETURNED CHECK FEE:** There will be a fee of \$30.00 per check and service will be suspended until all fees are paid in full.

**UNPAID BILLS:** If a customer leaves the landfill without paying applicable charges, the contractor will file charges with the Del Rio Police Department.
